Schnucks Stores:

Schnucks Grocery Stores and Knights of Columbus have come together to help our Developmental Disability Drive be as successful as it can be. With the talks, Schnucks agreed to have one Knights of Columbus council at each location in the State of Missouri, for the October 10-12 and they also agreed to October 17-19 that will be used for overflow at certain stores.

How this is going to work, each council will get a store on one of the two weekends. In the areas where there are multiple councils bidding for the same store, one council will get the first weekend and the other will get the second weekend. My choice for the first weekend is the council that turned in the most money to Columbian Charities for the drive from the previous year. There will be one insurance policy sent to the Schnucks Corporate office that will be in force for all the stores in Missouri. No longer will each store require a specific policy.

All councils that have a drive should be able to have a Schnucks store for one of the two weekends. It needs to be fair. There are only a few places that a council would want two or more stores and between Schnucks and myself we will determine what council would be at those stores. With multiple stores some councils may be setup for the second weekend to accommodate councils. I encourage all councils that want a weekend at Schnucks email me with Council#, date of drive (either weekend), contact person, and Schnucks Store location. KofC Councils will be collecting donations to help people with intellectual disabilities in our community at the Schnucks Approved Store Locations.

- 1. KofC Volunteers will be on-site at this location on FRI OCT 10 thru SUN OCT 12 and FRI OCT 17 thru SUN OCT 19 2025.
- 2. Fridays: 4 p.m. 8 p.m.; Saturdays and Sundays; 10 a.m. 6 p.m.
- 3. KofC Volunteers will be collecting donations to help people with intellectual disabilities in our community to patrons of Schnucks and the general public for the time frame(s) listed above.
- 4. KofC is not allowed to petition or collect signatures in or near Schnucks stores at any time. Further, literature distribution is prohibited, except for those instances where customers are being asked to purchase in-store items for donations as a part of

the solicitation event. In those instances, only distribution of "grocery lists" are permitted but must be reviewed and approved by Schnucks prior to the event.

KofC agrees to the following mandatory requirements:

- 1. KofC volunteers may sit/stand near only one store entrance or exit and may not interrupt access in or out of the store.
- 2. KofC may not interfere with any customers' shopping experience. If customer complaints are received about the method or behavior of any solicitation event participant, store management may ask that the solicitation event end and KofC agrees to comply.
- 3. KofC agrees to notify Store Manager/Customer Service upon arrival at the locations, both so leadership may direct the organization where to set up. KofC agrees to notify the Store Manager/Customer Service just ahead of departure and agrees not to leave any items at the locations.
- 4. KofC is responsible for providing any materials (product, table/chairs [as approved by SMI] etc.) necessary for the event, for setup and breakdown of any such materials, and for removing any event-related items from the property.
